Each party agrees that it shall have no remedies in respect of any representation or warranty (whether made innocently or negligently) that is not set out in this Release.

If any wording in this Release is held, in part or in full, to be invalid or unenforceable for any reason, the validity of the remaining clauses of this Release shall not be affected, and they shall continue to be valid and enforceable. The invalid and unenforceable provision shall be replaced with a valid provision which is as similar as possible in substance to the invalid or unenforceable provision.
10. This Release and any disputes arising out of or in connection with it shall be governed by and construed in accordance with the laws of the jurisdiction of the signatory’s residence.

**DATA PROTECTION NOTICE**

For the purposes of this Release, the data controller is the NIKE entity referenced above. In completing the Image Release Form and allowing NIKE to use the Image, you will provide NIKE with certain personal data, including your image, contact details and personal details.
